

**TOWN OF KIAWAH ISLAND TOWN COUNCIL
COMPREHENSIVE PLAN AMENDMENT PUBLIC HEARING
CODE TEXT AND ZONING DISTRICT MAP AMENDMENT PUBLIC HEARING
DEVELOPMENT AGREEMENT AMENDMENT PUBLIC HEARING**

The Town of Kiawah Island Town Council will hold three public hearings on Monday, September 30, 2013 starting at 1:00 p.m. in the Town of Kiawah Island Town Hall, 21 Beachwalker Drive, Kiawah Island, SC to gather comments from the public on proposed Comprehensive Plan Amendments (starting at 1:00 p.m.), Code Text and Zoning District Map Amendments (starting at 2:00 p.m.) and Development Agreement Amendments (starting at 3:00 p.m.) for parcels being considered for annexation into the Town of Kiawah Island. Comprehensive Plan Amendments include: applicable text and maps for the proposed annexation of the parcels listed below including but not limited to; all applicable elements and maps in the Comprehensive Plan.

Code Text Amendments include: adding an existing community dock located at TMS numbers: 205-00-00-123 and 205-00-00-244 to the Dock Key Locations text and map in the Land Use Planning and Zoning Ordinance, including but not limited to properties in Cassique that have deeded dock entitlements and to clarify the definition of "Community Dock" as set forth in the Land Use Planning and Zoning Ordinance and in the Development Agreement for Captain Sams Spit as previously decided by an arbitrator.
